## \*\* HEADSTONE OR MARKER

THE DEPARTMENT OF VETERANS' AFFAIRS WILL FURNISH A GOVERNMENT MARKER.

## \*\* VA BURIAL ALLOWANCE

THE BENEFIT IS ISSUED ONLY UNDER THESE CIRCUMSTANCES:

- (1) A SERVICE RELATED DEATH
- (2) THE PERSON IS A RECIPIENT OF VA PENSION
- (3) DEATH OCCURRED IN A VA HOSPITAL

# FILING FOR BENEFITS:

# \* APPLICANTS FOR BURIAL BENEFITS <u>MUST</u> HAVE THE PAPERS LISTED BELOW AT THE TIME OF APPLICATION.

- 1) DISCHARGE OF DD 214 (SEPARATION RECORD OF VETERAN)
- 2) CERTIFIED COPY OF DEATH CERTIFICATE
- 3) BURIAL PLOT DEED OR RECEIPT (IF NOT INCLUDED ON THE FUNERAL BILL)
- 4) ITEMIZED FUNERAL BILL

# \*\* SURVIVING WIDOW PENSION

THIS PENSION IS GRANTED TO ONLY THOSE WIDOWS WHO EARNED LESS THAN THE GOVERNMENT STATED INCOME. THIS FIGURE VARIES ACCORDING TO THE NUMER OF DEPENDANTS OR CHILDREN EARNINGS INCLUDED IN THE TOTAL INCOME FIGURE. WHEN FILING FOR THE PENSION MAKE SURE YOU HAVE ALL THE NECESSARY INFORMATION LISTED IN 1 THRU 8.

## \*\*\* APPLICANTS FOR SURVIVING WIDOW OR CHILDREN PENSION <u>MUST</u> HAVE THE FOLLOWING PAPERS IN ADDITION TO THE ONES LISTED ABOVE:

- 5) MARRIAGE CERTIFICATE OR DIVORCE RECORDS OF PREVIOUS MARRIAGES FOR BOTH THE WIDOW AND VETERAN
- 6) CHILDRENS BIRTH CERTIFICATES AND SOCIAL SECURITY NUMBERS
- 7) AMOUNT OF LIFE INSURANCE PROCEEDS
- 8) INCOME SOURCES: EARNINGS, SOCIAL SECURITY, ANNUITIES, RETIREMENT DIVIDENDS, INTEREST, STOCKS, BONDS, ETC...
