



## Anne D. (Waszil) Case

December 30, 1915 - April 5, 2021

Anne D. (Waszil) Case, “GG”, age 105, of Mentor, passed away peacefully Monday April 5, 2021 at her daughter’s home surrounded by her loving family. She was loved by all who knew her and will be remembered fondly as a sweet lady who lived a great long life but never grew old.

Anne was the first of her siblings born in America on December 30, 1915 in Lowber, PA. Her family moved to Cleveland in 1929. She worked pressing clothes in the laundry until, in 1936, she married Joseph Case. “Papa Joe” won her hand as the best polka dancer who brought her a gardenia to wear in her hair every week at the local dance. They enjoyed 58 years of marriage until he passed away in 1994.

Anne was also known as Aunt Annie to some and, after becoming a Great Grandma, mostly referred to as “GG.” She enjoyed preparing traditional Hungarian dishes (stuffed cabbage and chicken paprikash) and pastries for family gatherings and parties. She decorated homemade cakes for her family and shared large batches of her famous chocolate chip cookies generously, even toting them to grandparents’ weekends at UT and OU. Her favorite hobbies were dressing fashionably, Sunday morning breakfasts at Baker’s Square, babysitting great grandchildren, hairdos at the beauty shop, Polka dancing, and home decorating, especially for Christmas (she started in October!) She could iron the wrinkles out of anything, so her family always

looked sharp! She was always so full of love for everyone and would light up just to see you. She would squeeze your face in her hands when she kissed you, give crushing hugs, and tell you she loved you and didn't ever want to let go! She enjoyed fooling people by looking so much younger than she was and her laugh was infectious. So many people adopted GG as their "other Grandma."
